This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

This product is a bearer bond issued under German law.

The product has a fixed lifetime and will be due on the Redemption Date.

Objectives

Objective of the product is to provide you with a specified entitlement according to predefined conditions. Unless the Price of the Underlying is equal to or below the Barrier at least once during the Observation Period, you may benefit from a positive and a negative performance of the Underlying.

The possibilities for the redemption of the product are as follows:

- (i) If the Price of the Underlying is always above the Barrier during the Observation Period, you will receive on the Redemption Date a Redemption Amount which is equivalent to the product of (1) the Nominal Amount and (2) the sum of one and the absolute value of the Performance of the Underlying. The Performance of the Underlying corresponds to the difference between (1) the Reference Price divided by the Strike Price and (2) one. Due to the Cap the Redemption Amount cannot be more than the Maximum Amount.
- (ii) If the Price of the Underlying is equal to or below the Barrier at least once during the Observation Period, you will receive a Redemption Amount which equals the Nominal Value multiplied by the Reference Price divided by the Strike Price. Due to the Cap the Redemption Amount cannot be more than the Maximum Amount. You will make a loss in case the Redemption Amount is below the purchase price of the product.

You renounce the entitlement to a dividend from the components of the Underlying and you have no right to any further entitlement resulting from the components of the Underlying (e.g. voting rights).

2. What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class.

This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you.

3. What happens if XY Bank is unable to pay out?

In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. 5. How long should I hold it and can I take money out early?

If you should sell the product before the end of the recommended holding period, the amount you will receive could be – even significantly – lower than the amount you would have otherwise received.
